








Value vs. Growth relative valuations



Value vs. Growth: Cash, R&D and capex










Sector composition

% of index market capitalization










Real GDP




Components of GDP growth

q/q % change, annualized rate







Specifically, they consider real personal income less transfers, nonfarm payroll employment, employment as measured by the household survey, real personal consumption expenditures, wholesale-retail sales adjusted for price changes and industrial production. There is no fixed rule about which measures contribute to the process or how they are weighted, but the committee notes that "in recent decades, the two measures we have put the most weight on are real personal income less transfers and nonfarm payroll employment."




Residential investment as a % of GDP

Quarterly, seasonally adjusted




Light vehicle sales

Mil vehicles, seasonally adjusted ann. rate




Business fixed investment as a % of GDP






Federal deficit and net interest outlays

% of GDP, 1940 - 2034, CBO Baseline Forecast, end of fiscal year






Household debt service ratio













Total job openings, thousands, seasonally adjusted




JOLTS quits














Contribution to y/y % change in CPI, non-seasonally adjusted














Index weighting by credit rating


State and local and federal net debt




Bloomberg U.S. Agg. annual returns and intra-year declines
















Interest rate expectations by country




Intl. dev. relative valuation vs. the U.S. by sector

Forward P/E ratio, premium or discount vs. the U.S.







Year-over-year % change, contribution by component























Private vs. public equity sector weights




















Consumer confidence by political affiliation

Percentage of Republicans and Democrats who rate national economic conditions as excellent or good






